

### Graduate-On-Time (GOT) Model

We pioneered the executive doctorate program in Africa. As a new business school, we started from a clean slate, so we do things differently to create an executive-friendly Graduate-On-Time (GOT) Model that takes care of your concerns.



### **Executive-friendly creative** program design and delivery

Each course is delivered face-to-face on campus and, where necessary, LIVE online sessions in a BLOCK FORMAT over 2 - 3 days every few months. The program schedule is given to you in advance to allow you to plan your busy calendar.



## Completion

You start your doctoral thesis work from day one. We combine coursework with thesis writing to ensure that all your assignments are related to your thesis. This approach ensures speed and timely completion by avoiding the problems associated with the traditional method of thesis completion.



### Thesis **Supervision System**

We have a creative supervision system in which a lead supervisor works with a group of lecturers and research fellows, and external thesis readers on your thesis. Our approach ensures effective monthly feedback sessions and interaction between you and the lead supervisor. We use the journal peer review process as an additional level of supervision.



### Supervisor Feedback **Service Promise**

We have developed specific periods for supervisors and lecturers to provide feedback on examinations, assignments, and thesis chapters. We encourage students to report any service failure for remedial action.



Under agreed policy guidelines, full-time research fellows assist you in research over the entire duration of the program.



Under the traditional education model, thesis writing is unstructured, ad-hoc, and lonely. No wonder many students complete the coursework and never get to complete the thesis. We organize a hands-on thesis writing workshop either online or on-Campus, where students receive guidance from the supervision team supported by Research Fellows. Each thesis writing workshop lasts a minimum of 8 hours.



We encourage and work with each student to produce a research publication before graduation.



### Scholarships & Installment Fee Payment Plan

We offer scholarships of significant value to students who meet certain conditions and flexible payment terms.

# Academic Ph.D. vs. Professional Doctoral Programs

## Similarities

Both the academic Ph.D. and professional doctoral programs have essential similarities

- Participants in both types of programs earn the 'Doctor' title as a result of completing the doctoral dissertation
- The duration of both programs is typically three years
- Faculty with doctorates teach both programs
- Participants in both programs conduct original research that must contribute new knowledge of practical value.
- Graduates are trained to teach and publish research output

## Differences

There are important distinctions between the two types of doctoral programs.

# Doctor of Philosophy (Ph.D.) in Business Administration

### OVERVIEW

The Academic Ph.D. program prepares candidates for research and teaching careers in higher education and occupations requiring advanced research and analytical capabilities in research departments, consulting, banking, government, etc. You will:

- Acquire the knowledge and expertise required to identify, understand, and successfully tackle a key research issue in a specialized business and management study area.
- Develop analytical and research skills in formal social inquiry required to define and address a complex issue in-depth.
- Demonstrate expertise in a specific topic area through designing, executing, and completing a doctoral thesis that contributes new theoretical and empirical knowledge and practice.
- Demonstrate ability to disseminate new knowledge through publications in academic and practitioner journals and other outlets.
- Develop critical skills in designing and delivering educational courses through understanding the theory and practice of teaching in tertiary institutions.

### SPECIALIZATIONS

You have an opportunity to specialize and complete your thesis in one of five disciplinary areas:

- Marketing
- Finance
- Strategy & Innovation
- Management
- Organizational Leadership

### TYPE OF CANDIDATES

The Ph.D. in Business Administration program attracts two types of candidates:

- Young graduates who want to become university faculty to research to add to the body of knowledge in their chosen disciplines.
- Experienced business executives who would

like "to give something back" by becoming effective educators in Universities may be considered case by case.

### ADMISSION REQUIREMENTS

- Master or MPhil Degree in business, management, and related areas,
- Applicants must attain a minimum GPA of 2.75.
- Applicants with a professional accounting qualification, e.g., ICAG, ACCA, CIMA, etc., in addition to a non-research EMBA, a non-business-related MBA, MA, or MSc from an accredited university/college with a minimum 3.0 CGPA, must complete a foundation bridge program.
- International applicants may be admitted based on qualifications from their home country universities, for which equivalence shall be determined by the Ghana Tertiary Education Council (GTEC) and submitted to the university.
- Applicants from non-English speaking countries need to provide evidence of English language proficiency.

The mission of the DBA program is to develop executives to more effectively understand new trends in business & management so that they can assume senior management and leadership responsibilities. It aims to:

- Enable experienced executives to develop a deeper understanding of management theory and research.
- To demonstrate expertise in a specific topic area through designing, executing, and completing a doctoral thesis that contributes to knowledge and practice of the field.
- To demonstrate the ability to disseminate new knowledge through publications in practitioner journals, conferences, and, where possible, academic outlets.
- To develop critical skills in designing and delivering educational courses through understanding the theory and practice of teaching in business in tertiary institutions

### TYPE OF STUDENTS

 The DBA attracts participants who are working professionals or senior managers with deep professional experience and substantial standing in their respective fields

### ADMISSION REQUIREMENTS

- Master's degree in Management, Business (e.g., MBA) with five years of management experience, or
- Professional qualification such as ACCA, and ICA, that demonstrates foundation knowledge of business and management; with five years of management experience, or
- First degree in business and management with a minimum of 10 years of management and leadership experience, or
- Master's degree in non-business discipline – must complete and pass at credit level the foundation program.
- International applicants may be admitted based on qualifications from their home country universities, for which equivalence

shall be determined by the Ghana Tertiary Education Council (GTEC)

• Applicants from non-English speaking countries need to provide evidence of English language proficiency.

# Doctor of Business Leadership (DBL)

### OVERVIEW

The NiBS DBL program is designed to develop and prepare executives to assume overall leadership responsibility within organizations operating in intensely competitive national and global markets. It aims to:

- Enable business leaders to develop their skills in understanding, evaluating, and creating new knowledge within their profession, thereby contributing to the development/enhancement of professional practice in business leadership.
- Enable experienced business leaders to develop a deeper understanding of leadership theory and research.
- Develop practitioner-scholars who will conduct and publish the results of rigorous applied leadership research that advances an area of knowledge and practice.
- Develop academically sound business leaders who can teach/transfer their knowledge in the various fields of leadership and governance.
- Produce a thesis or portfolio based on high-quality original research of publishable standard (suitable for dissemination into their profession).

### TYPE OF STUDENTS

 The DBL attracts participants holding board and other senior leadership positions in private and public sector organizations. They have deep professional leadership experience and are of substantial standing in their respective organizations.

- Master's degree in Management and Business (e.g., MBA) with five years of management experience, or
- Professional qualification such as ACCA, and ICA, that demonstrates foundation knowledge of business and management; with five years of management experience, or
